4.1 Brian Kelly, Member, Whitby Sustainability Advisory Committee

Re: The Kelly Household's Journey Towards Zero Carbon and Sustainability Finance Forum

Brian Kelly provided a presentation regarding The Kelly Household's Journey Towards Zero Carbon and Sustainability Finance Forum. Highlights of the presentation included:

- detailed information about Step 1: New House Retrofit, Step 2: Electric Vehicle, Step 3: Photovoltaic System (PV), Step 4: Heat Pump, and Step 5: Heat Pump Water Heater;
- details about the costs and saving related to the electric vehicle purchased by The Kelly Household, as well as the expenditures, rebates, and savings for the photovoltaic system and the heat pump;
- information about the carbon fee-bate; and,
- lessons learned throughout the process.

A question and answer period ensued regarding:

- the possibility of receiving monetary reimbursement for the furnace and air conditioner upon their removal;
- whether the existing air ducts in the house were used for the installation of the new heat pump; and,
- justification for choosing an air source versus a ground source heat pump.

Brian Kelly provided an overview and the objective of the Sustainability Finance Forum conference that took place in Ottawa.
