- clarification about paternity leave resulting in overtime; and,
- confirmation that \$355 million was the total balance of all reserve funds.

Re: Leases with Bell Mobility Inc. at 57 Winchester Road East and 333 McKinney Drive

That the Mayor and Clerk be authorized to enter into a five (5)-year lease agreement with Bell Mobility Inc., with a commencement date of August 1, 2026 to extend the lease of property for a telecommunications tower at the land municipally known as 333 McKinney Drive as outlined in Staff Report FS 31-25; and,
- 3. That the Commissioner, Financial Services/Treasurer be authorized to negotiate and execute future renewals of telecommunication tower Lease Agreements provided that the renewal is based upon the similar general terms and conditions as the original telecommunication tower leases and subject to the satisfaction of the Commissioner, Legal and Enforcement Services/Town Solicitor.
